**Article i 1 this convention shall apply to the recognition and enforcement of arbitral awards made in the territory of a state other than the state where the recognition and enforcement of such awards are sought and arising out of differences between persons whether physical or legal**

Where enforcement is sought in one of these states the best solution will be if there exists a bilateral or multilateral treaty for the recognition and enforcement of arbitral awards to which both the state of the arbitral seat and state in which enforcement is sought are parties but this is not always the case.
